Special Instructions Regarding Refrigerants:

Refrigerants must be removed and recovered from appliances such as freezers and air conditioners before they can be accepted at the Transfer Station. A refrigerant certification form must also be signed before this type of appliance can be accepted. Refrigerants can be recovered by many of your local heating and cooling contractors.

General Information

The Marion County Transfer Station is open to the public from 8:00 a.m. to 4:00 p.m. Monday through Friday, and from 8:00 a.m. until

Attendants are on hand to assist you .



12:00 p.m. on Saturday. The Station is closed Sunday and on all County holidays.

We strongly recommend that all loads be covered to prevent spillage en-route to the transfer station.

Attendants are on hand to assist you. Please wait for an attendant before unloading any materials.

For everyone's safety, please do not allow children or pets out of vehicles while on the unloading floor.

For waste that incurs a fee, payment is due at the time of unloading. (See Fee Schedule) Cash or checks are accepted. No amounts will be "charged on account."

Acceptable Types of Waste

What types of waste can I dispose of at the Transfer Station?

- <u>Municipal Solid Waste</u> such as household garbage, trash / junk.
- Construction and Demolition Waste such as lumber, carpet, and roofing materials.
- White Goods such as washing machines and refrigerators.
- Tires
- Special Waste Prior approval is required.

UNACCEPTABLE Types of Waste

What types of waste *cannot* be disposed of at the Transfer Station?

- <u>Hazardous Waste</u> such as paint, oil, car batteries, pesticides.
- Yard Waste such as grass clippings, leaves and branches.

Contact the Marion County HHW Dept. for details on the disposal of Hazardous Waste at (620)382-3190. **Fee Schedule** How much does it cost to dispose of wastes at the transfer station? All disposal costs for municipal solid waste generated in Marion County are paid for through a solid waste service fee assessment included with your annual county property taxes.

- Residences are charged \$81.00 annually per unit of solid waste.
- Businesses are charged \$132.00 annually per unit of solid waste.

This fee does not include collection. It includes disposal of: municipal solid waste, white goods, and up to one cubic yard of construction and demolition waste per generator per week.

- Generators with volumes of construction and demolition waste over one cubic yard are charged \$40 per ton.
- Generators of out-of-county waste are charged \$40 per ton.

Waste Tires are charged as follows:

Car Tires \$ 2.00 each

• Truck Tires \$5.00 each

Tractor Tires \$17.25 each

Payment is due at the time of unloading. Cash or checks are accepted.
