Commission met in regular session at 9:00 a.m. in Commission chambers at the Marion County Courthouse with Chr. Jonah Gehring, Comm. Kent Becker, Comm. Randy Dallke, Comm. Dave Crofoot, and Comm. Dianne R. Novak present. Also present was Co. Clerk Tina Spencer. Present for portions of the meeting were County Counselor Brad Jantz, Commissioner-Elect David Mueller, County staff, members of the public and members of the press.

PUBLIC COMMENTS: None.

COVID-19 UPDATE: Health Officer Diedre Serene reported 37 active cases and six hospitalizations. The County's rolling positivity rate is 21%.

ADMINISTRATIVE: Becker moved to approve the minutes of December 21st. Dallke seconded and motion carried 5-0.

- Change orders affecting the 2020 tax roll were reviewed and signed by the Board.
- The Commission clarified that December 31st will be a regular workday for County employees.

A cents per-hour raise was also discussed (instead of an across the board percentage). Spencer was directed to prepare some cost scenarios for the next meeting.

- Novak commented that the McPherson County Commission has now banned all wind turbines in McPherson County and has removed certain authorities from the Planning Commission there.
- Dallke noted that the vision of the Planning Commission needs to align with the vision of the governing body to be successful.

Counselor Brad Jantz joined the session at 10:15 a.m. Gehring moved to recess into executive session to discuss personnel performance pursuant to K.S.A. 75-4319b (1) for personnel matters of non-elected personnel for 10 minutes with the Board and Jantz present (until 10:28 a.m.). Becker seconded and motion carried 5-0.

Open session resumed with a motion by Gehring to recess into executive session to discuss personnel/performance pursuant to K.S.A. 75-4319b (1) for personnel matters of non-elected personnel for 10 minutes with the Board and Jantz present (until 10:42 a.m.). Dallke seconded and motion carried 5-0. Open session resumed with no action.
