District #1 Commissioner Kent Becker was sworn into office by Judge Michael Powers at 8:30 a.m. in the main floor hallway of the Marion County Courthouse with a reception following.

Commission met in regular session at 9:00 a.m. in the Commission chambers at the Marion County Courthouse with Chr. Dianne R. Novak, Comm. Kent Becker, and Comm. Randy Dallke present. Also present was Tina Spencer, Marion County Clerk. Present for portions of the meeting were Co. Counselor Brad Jantz, Gene Winkler, Tom Britain, Henry Ethem, Dick McLinden, Carl Stovall, Robert Craft, Lloyd Meier, Jonah Gehring, Don Stenzel, Brad Pagenkopf, David Hein, (illegible name), Mark Wiebe, Trent Hajek, Brian Hanschu, Leona Hajek, Ron Hajek, Brett Hajek, Cynthia Davis, Tina Steele, Mike Beneke, and members of the press.

ADMINISTRATIVE:

- **Reorganization of the Board:** Novak moved to appoint Kent Becker as Chairman of the Board for 2019. Dallke seconded and motion carried 3-0. Novak moved to appoint Randy Dallke as Vice Chairman. Becker seconded and motion carried 3-0. Chairman Becker presided over the remainder of the meeting.
- Mileage Rate: Novak moved to set the mileage reimbursement rate at 58cents/mile as set by Internal Revenue Service. The approved mileage rate was incorporated into resolution format. Dallke seconded and motion carried 3-0. Novak moved to adopt Resolution 2019-1 establishing the mileage rate for County business conducted in personal vehicles. Dallke seconded and motion carried 3-0.
- Legal Publisher: Dallke moved to continue with Marion County Record as the legal publisher (as established in Resolution 2018-02). Novak seconded and motion carried 3-0. The rates will be the same as the previous few years.
- Banks: Dallke moved to deposit County funds in all financial institutions located within Marion County that are authorized by law. Novak seconded and motion carried 3-0. The working bank is Marion National Bank for 2019.
- Outside Boards: Outside board appointments were reviewed, and the proposed assignments discussed were:

EMERGENCY MANAGEMENT: Dir. Randy Frank provided a quarterly update for the Board. Frank provided a Resolution for review that would allow a verbal disaster proclamation by the Chairman outside a regular or special meeting of the Board. No decision was made.

SHERIFF: Sheriff Rob Craft provided a quarterly update for the Board. The 2018 Asset Forfeiture report was provided pursuant to K.S.A. 60-427. Total cash seized was \$936.00. Also seized was a 2002 Mitsubishi Montero valued at approximately \$2,500.00.

FIRE CHIEFS: Matt Voth, Lester Kaiser and Ben Steketee addressed the Board on behalf of the Fire Chiefs. Several topics were discussed for future consideration of the Board: the lack of a written agreement for housing the Goessel first response unit, a request for additional County funding of district radios, and problems with radio signal strength in certain areas of the County. No decisions were made, but the consensus of the Board was for the Chiefs to move ahead with gathering information for potential improvements for signal strength and to bring options back for consideration.

CEREAL MALT BEVERAGE REQUEST: Co. Counselor Brad Jantz joined the session. Janice Davis, owner of Last Chance Bait requested reconsideration of the denial of a cereal malt beverage license for her business. The issue was discussed at length. The consensus of the Board was to abide by the advice of legal counsel and not grant a CMB license.

PUBLIC COMMENT: Mike Beneke suggested that Park & Lake Supt. Isaac Hett attend area sport, boat and travel shows to promote the County Lake.
