March 31, 2021

Commission met in special session for payday and other business at 9:00 a.m. in Commission chambers at the Marion County Courthouse with Chr. Randy Dallke, Comm. Dave Crofoot, and Comm. Kent Becker present. Comm. Jonah Gehring joined at 9:02 a.m. Comm. David Mueller joined at 9:19 a.m. Also present was Co. Clerk Tina Spencer. Present for portions of the session were County staff, members of the public, and members of the press.

SALES TAX: Sales tax for the month of January, 2021 was received in the amount of \$77,951.54.

PAYDAY: The monthly cumulative comp time report was reviewed.

- A detailed list of expenditures by fund was reviewed. A report showing payments to Western Associates and Elcon Electric was reviewed.
- Becker moved to approve payments to Western Associates in the amount of \$307.00. Dallke seconded and motion carried 4-0 with 3 in favor and Crofoot abstaining due to conflict of interest (abstention counted with majority prevailing).
- Becker moved to approve payments to Elcon Electric in the amount of \$682.05. Crofoot seconded and motion carried 4-0 with 3 in favor and Gehring abstaining due to conflict of interest (abstention counted with majority prevailing).

- Encumbrances from the 2020 budget were reviewed. All expected invoices have been paid. Dallke moved to cancel encumbrances in the amount of \$8,725.35. Gehring seconded and motion carried 4-0.

Gehring seconded and motion carried 4-0. Comm. Mueller joined the session in process. Open session resumed with no action.
