

**RECORD OF PROCEEDINGS
BOARD OF COMMISSIONERS
MARION COUNTY, KS**

November 12, 2021

Commission met in special session at 8:45 a.m. in Commission chambers at the Marion County Courthouse with Chr. Randy Dallke, Comm. Dave Crofoot, Comm. Jonah Gehring, and Comm. David Mueller present. Comm. Kent Becker was absent.

PERSONNEL/HIRING: Dallke moved to hire Krista Schneider as the Marion County Health Department Director / Public Health Officer effective December 20, 2021 at a monthly salary of \$6,633.00/month plus \$300.00/month on call pay from PHEP grant funds with two weeks' vacation to be banked immediately upon hire – with an additional \$1.00/hour equivalent granted at the end of each the first and second year of employment with satisfactory performance. Crofoot seconded and motion carried 4-0.

The Board thanked the current Health Department staff for keeping everything running smoothly despite additional activities (Health Fair, flu clinics, COVID boosters and more) and without a Department Director.

Dallke and Mueller reported that they had looked at a road in another County that had the full-depth reclamation process done by a different contractor than the one Marion County used on Nighthawk, and that the end product was almost identical.

Dallke moved to adjourn the meeting and reconvene at 9:00 a.m. as the Board of Canvassers. Gehring seconded and motion carried 4-0. Meeting adjourned at 8:53 a.m.

CANVASS 2021 GENERAL ELECTION: The Board convened as the Board of Canvassers at 9:00 a.m. in Commission chambers. Gehring moved to appoint Jo Ottensmeier to serve on the Board in place of Comm. Becker, who was absent. Dallke seconded and motion carried 4-0.

Spencer reviewed the Election Summary Report. Election results and other documentation were provided for review.

- The provisional ballot summary was reviewed. Gehring moved to fully count 15 provisional ballots, partially count 4 provisional ballots and not count 12 provisional ballots based on the recommendations given. Crofoot seconded and motion carried 5-0.
- Gehring moved to count (separately recorded) write-in votes for Anjanette Vinduska and Anjanette Vinduska Godinez together for the Pilsen Improvement District Director race. Mueller seconded and motion carried 5-0.
- The provisional ballots approved to be counted were opened and tabulated and the vote totals combined with previous results (including write-ins).
- Dallke moved to recess for 30 minutes until 10:45 a.m. Mueller seconded and motion carried 5-0.
- Finalized results were reviewed. Gehring moved to accept the election results and certify the winners. Mueller seconded and motion carried 5-0.

Gehring moved to adjourn. Dallke seconded and motion carried 5-0. Canvass adjourned at 10:55 a.m.
