



Senior Food Boxes

The Marion County Food Bank offers Senior Food Boxes once a month. To apply you can pick up an application at the Marion County Food Bank, Marion County Dept. on Aging or call 316-265-3663. You will need to provide

a valid driver's license or State I.D. for everyone in the household, proof of addressutility bill, lease rental agreement, bank statement and proof of income-pay stubs for the past 30 days, or a Social Security statement, unemployment and

any retirement information such as pension received. Eligibility: You must be 60 years of age or older and meet income guidelines. You have to reapply every vear to continue to receive the Food Box.

USDA Commodities

Since last Spring we have been receiving USDA Commodities each month. We are now receiving frozen meat and fruit, nuts and canned items. The distribution date is the third Wednesday of the month: March 17, April 21, May 19, June 16, July 21, August 15, September 15, October 20, November 17 and December 15. The following sites and distribution times are as follows: Wednesday-Burns **Community Center**morning, Goessel Mennonite Church-5:00 p.m., **Lincolnville Community** Center-10:30-11:00 a.m., **Lost Springs-Marion Sr.** Center-11:00 a.m., Marion Sr. Center-10:00 a.m.-1:00 p.m., Peabody Sr. Center-10:00-11:30 a.m., Ramona Community Center-morning and Tampa Sr. Center-3:00-4:00 p.m. Thursday-Florence-9:00-11:00 a.m. Saturday-Hillsboro Main St. Ministries-9:00 a.m.-Noon. (pick up site for Lehigh and Durham residents). You must meet the follow-

ing Income Guidelines: Household size 1-\$1,383.00, 2-\$1,868.00, 3-\$2,353.00, 4-\$2,839.00, 5-\$3,324.00 and 6-\$3,809.00. The commodities are distributed first come first serve. You need to check with your local distribution site to receive your commodities. If your site does not have any left you can pick up in another com-



Did you get your \$600.00 Economic Stimulus Check?

Did you get your \$600.00 **Economic Stimulus Check** sent out the first of January? If not you need to file a Federal return. The only way you will get this \$600.00 is to file a 2020 return. The Marion County Dept. on Aging is helping individuals recoup their \$600.00. You will need to

bring in your Social Security 2020 benefit statement and any other income such as: pension, IRA distribution, bank interest, disability benefits (employer funded) dividends, farm income, gambling winnings, hobby income, railroad retirement, rents, selfemployment and unem-

ployment compensation. You have until April 15, 2021 to file a Federal return. Call 620-382-3580 and we can help you file.
