Contact members of the Republican Precinct Committee to secure a potential nomination and second. **One of the Precinct Committee Members MUST nominate you at the convention for you to be eligible for election by the Precinct Committee, and the nomination must be seconded by at least one other Committee Member.** *(You may wish to contact additional precinct committee members to share your qualifications and the reasons you believe that you should be selected.)*
3. Attend the convention at the Marion County Lake Hall, 1 Office Drive, Marion on Thursday, January 18th at 7:00 p.m. You will be notified by phone and/or email if the convention must be changed to an alternate date. Any candidates nominated at the convention will be allowed to speak, according to the Party's rules, and will be expected to answer questions asked by the Committee.

2022 Kansas Statutes

19-301. County clerk; election, term, bond. Beginning with the general election in 1976, a county clerk shall be elected in each county, for a term of four (4) years. Such county clerk shall, before entering upon the duties of the office, execute and file with the county treasurer a good and sufficient corporate surety bond, conditioned on the faithful performance of the duties of the office. Such bond shall be issued by a company authorized to do business in Kansas, in an amount to be fixed by the county treasurer of not less than ten thousand dollars (\$10,000).
