## **Over the Counter Hearing Aids**

This past October individuals started buying over the counter (OTC) hearing aids in stores and online. In the past in order to get a hearing aid you needed a prescription. The OTC hearing aids are for adults. (18 or older) who believe they have mild to moderate hearing loss, even if they have not had a hearing exam. If you have a hard time hearing when you're in a group, on the phone or when you can't see who is talking or turn up the volume

higher on tv/radio then these OTC hearing aids might be helpful. The FDA has established regulations that manufacturers of OTC hearing aids need to follow. They must ensure that the OTC devices are safe and effective for people. They have set standards for package labels to help buyers understand OTC hearing aids and who might benefit from them. The labels also include warnings and other information you should know before buying or when using the hearing aid, such as signs that indicate that you should see a doctor. What should you know before buying an OTC hearing aid. While it's not required, it's still recommended that you speak with a licenses audiologist to determine your exact hearing aid needs. Here are five steps to review when getting ready to buy an OTC hearing aid. First, determine which style works best for you in the canal, behind the ear, receiver (Over the Counter Hearing Aids see Pq. 3)

Our office has received word from several Marion County residents that they have received COVID test kits in the mail. They did not order the test kits. These are not free because the Federal government stopped sending out free test kits in September These kits may have been billed to your Medicare. Some people who received the tests say they are out of date. Medicare is saying if you received these in the mail to call them and let them know at 1-800-633-4227. They will ask you to

#### mail them back to the company. This is key to mailing them back is DO NOT **OPEN** the package or you will have to pay to mail them back. One Marion resident said their test kits came from the Fulfillment Center, 27111 W. Market, PO Box 5468, Fairlawn, **OH.** If you received COVID tests early in the year when you got them free be sure to check and make sure they haven't expired. Just some precautions headed into the rest of the holiday season. If you haven't got your new

booster which came out this fall you might want to consider getting it before you gather with family. If you are gathering with family for the Christmas holidays you might want to minimize your exposure in the week before the holiday. That means wearing a mask in public indoor spaces. #### Inflation Reduction Act what's in it for Seniors

The Inflation Reduction Act passed this August includes many benefits for seniors. Starting in January 2023, people enrolled in a Medicare Prescription Drug Plan will not pay more than \$35.00 for a month's supply of each insulin that they take and is covered by their Medicare Prescription Drug Plan. The Part D deductibles won't apply to the covered insulin product. Starting in July

people with traditional Medicare who take insulin through a traditional pump will not pay more than \$35.00 for a month's supply of insulin. The adult vaccines recommended by the Advisory Committee on Immunization Practices, including the shingles vaccine, will be available to people with Medicare Part D at no cost to them. Come this September, CMS will announce the first 10 Medicare Part D drugs selected

for the Drug Price Negotiation Program. Maximum fair prices negotiated for these first 10 Part D drugs will go into effect in 2025.

receiver in the ear. The National Council on Aging website tells you the pros and cons of each style and fit. Second review the features such as are you looking for noise reduction, rechargeable batteries, wireless connection, telecoils, directional microphones or remote control. Third ask for a trial period. Many hearing aids come with trial period. Have the dispenser put in writing the cost of a trial, whether this amount is credited toward the final cost of the hearing aid and how much is refundable if you return the hearing aids. Fourth check to see if there is a warranty. Finally compare the cost of the device. Make sure to shop around and do your research.
