

It will contain any changes to your plan such as premium, deductible and formulary changes. The deductible is going up to \$480.00 on most plans and to reach the donut hole this year your medications cost is \$4,430.00. I strongly encourage you to read the material your plan

Getting Everything You May Be Entitled to with Medicare

Many of you see almost daily a commercial by either Joe Namath, Jimmy Walker or Joan Lunden about calling to find out if you are getting everything you may be entitled to with Medicare. They are talking about a Medicare Advantage plan. You can enroll in an Advantage plan when you first turn 65, annual enrollment the same time as Prescription Drug **Open enrollment October** 15-December 7 or special enrollment anytime throughout the year because of the following changes: change where you live, losing your current health insurance, getting an opportunity to obtain other coverage, your **Medicare Supplement goes** out of business or your plan changes its contract

with Medicare. The benefits you deserve such as meals. rides to medical appointments, private home aides, over the counter medication allowance and free prescription delivery depend on vour zip code. Most of these additional benefits are available in health maintenance organization plans which means you must use their physicians, hospitals, dentist and eye doctor network. If you use any providers not in their network you will pay additional costs. The plan likely will require prior approval or authorization before receiving care, the plan must review and approve the physician's order. These additional benefits have limits. For example, two meals a day for five days after hospitalization with a limit of four hospital-

izations and private home aide four hours a day for no more than 31 days in a year. The commercial says all these benefits may be available at no additional cost to you but the small print at the bottom of the page says "Plan premiums, copayments, and coinsurance can apply. Zero premiums does not mean zero costs. Plan members will pay their share of costs until they reach the plan's out of pocket maximum limit on average is around \$5,000. Keep in mind that these **Medicare Advantage plans** are offered by for-profit entities. Before you make a switch do your research and be an informed shopper. Your Medicare coverage is too

important.

Medicare Fraud with Braces

I don't know if you have received a call asking if vou have back, knee, hip or other joint pain. If you say yes over the phone this gives this company permission to send you a brace. Unfortunately your name gets passed around to other companies and they start sending you braces. The braces you should have needs to be fitted to you and so getting one from one of these companies is probably not going to fit correctly. It is best to talk to your doctor

if you think you need a brace to help with pain or more support. So what should you do if you start receiving braces: 1. Refuse to accept the package when it comes to your home. 2. Don't open the contents if it is left on your doorstep, call the brace company to get a tracking return label. You have 30 days to return it before Medicare is billed for it. 3. If you open the package and see it is a brace do not take the brace out of its package bag, the company

can refuse to take it back. 4. If you continue to receive braces you need to call Medicare 1-800-633-4227 to report this fraudulent activity. 5. If you need help with this matter, please feel free to call the Marion Co. Dept. on Aging office 620-382-3580 and we can help.
