LEPP and WRAPS Program Participants:

As you may be aware, the current State Budget for Fiscal Year 2010 (July 1, 2009-June 30, 2010) reduces state funding levels for the Local Environmental Protection Program (LEPP) and the Watershed Restoration and Protection Strategy (WRAPS) program as shown below. The Legislature will reconvene on April 29, 2009, and complete the FY 2010 State Budget with the Omnibus budget bill.

We recognize these reductions will present challenges for implementing these programs and wanted you to be aware of these reductions as we begin preparing for FY 2010. Attached is a table showing the FY 2009 LEPP county allocations and an estimate of how the reduced program funding would affect those allocations based on the LEPP funding formula. The actual FY 2010 county allocations will depend on the total amount of the FY 2010 base grant applications submitted.

FY 2010 funding requests for WRAPS projects and service providers are currently under consideration based on review of the proposals submitted during the recent WRAPS application period. WRAPS allocations for FY 2010 should be finalized in May, which will include both state and federal Clean Water Act Section 319 funding.

We look forward to working with you to address the program implementation challenges in the coming fiscal year.
