Third Street, Marion, Kansas. The proposed amendments to the Marion County Zoning Regulations were prepared in accordance with K.S.A. 12-

741 et seg, and amendments thereto. by the Marion County Planning Commission to promote the health, safety, comfort and general welfare of the citizens of Marion County, Kansas, and address the elimination of the Overlay District designation for Commercial Wind Energy Systems thereby making the entire unincorporated portion of Marion County eligible for consideration for said development. Other topics on the same general subjects may be considered by the Marion County Planning Com-mission for amendment to the Marion County Zoning Regulations at this public hearing and included within any recommendations regarding the same to the Board of County Commis-

Any person wishing to be heard re-

garding this matter may submit written comments to the Marion County Planning Commission prior to or at the public hearing, or may present written and/or oral comments at such public hearing, All persons wishing to be heard concerning this matter shall be afforded an opportunity todo so.
