

RESOLUTION NO. 03-23

A RESOLUTION APPROVING AND ADOPTING A NEW COMPREHENSIVE PLAN IN ACCORDANCE WITH KSA 12-715 *et. Seq.*, AND REPLACING THE EXISTING COMPREHENSIVE PLAN AND ITS AMENDMENTS.

WHEREAS, the Planning Commission of Marion County has caused a Comprehensive Plan Update to be proposed for the County;

WHEREAS, the Comprehensive Plan Update includes the report prepared by the Planning Commission with the assistance of the County planning consultant, Bucher, Willis & Ratliff Corporation, and titled Marion County Comprehensive Plan and all maps, descriptive matter and other matters identified therein;

WHEREAS, a public hearing was held on November 8, 2001 after due notice was given on the issue of the Comprehensive Plan; and

WHEREAS, copies of the proposed Comprehensive Plan were available for review prior to the public hearing; and

WHEREAS, the November 8, 2001 public hearing was continued to November 15, 2001; and

WHEREAS, on November 15, 2001 a quorum of the Planning Commission was present to constitute a meeting; and

WHEREAS, the Comprehensive Plan and maps and other matters identified therein were discussed; and

WHEREAS, the Planning Commission did unanimously vote to adopt the Comprehensive Plan as the new Comprehensive Plan for the County; and

WHEREAS, the Planning Commission has submitted a certified copy of the new Comprehensive Plan and a written summary of the hearing thereon to the County Commission; and

WHEREAS, the Marion County Commission did return the new Comprehensive Plan to the Planning Commission with recommended changes to the plan.

WHEREAS, a public hearing was held on August 28, 2003 after due notice was given on the issue of the Comprehensive Plan; and

WHEREAS, copies of the proposed Comprehensive Plan were available for review prior to the public hearing; and

WHEREAS, the Planning Commission did unanimously vote to adopt the Comprehensive Plan with recommended changes as the new Comprehensive Plan for the County.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF MARION COUNTY, KANSAS:

Section I:

The document adopted by the Planning Commission entitled Marion County Comprehensive Plan, Summer 2003, is hereby approved as the new official Comprehensive Plan for Marion County, Kansas.

Section II:

The formerly existing Comprehensive Plan and any amendments thereto are hereby repealed.

Section III:

This resolution shall take effect and be in force from and after its passage, approval, and publication as provided by law.
